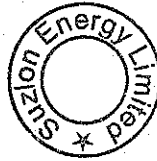

Suzlon Group wins 580 MW in new orders

- Cumulative order wins in three month period (between 15th February, 2013 and 15th May, 2013, excluding orders announced separately)
- Product mix include Suzlon's S82 and S88 turbines and REpower's 3.4M104 and 3.2M114 models, in addition to MM82, MM92 and MM100 types

Pune: Suzlon Group-subsiidiary, REpower Systems SE, today announced cumulative orders of approximately 580 MW over a three month period, excluding orders announced separately.

These cover various orders secured between 15th February, 2013 and 15th May, 2013 across Belgium, Canada, France, Germany, India, Poland and Sweden.
