Post aforesaid allotment, the paid-up capital of the Company is Rs.1764,12,26,010/- (Rupees One Thousand Seven Hundred Sixty Four Crores Twelve Lacs Twenty Six Thousand Ten Only) divided into 882,06,13,005 (Eight Hundred Eighty Two Crores Six Lacs Thirteen Thousand Five) equity shares of Rs.2/- (Rupees Two Only) each.
