Sub.: Qualified institutions placement of equity shares of face value Rs.2.00 each (the “Equity Shares”) by Suzlon Energy Limited (the “Company”) under the provisions of Chapter VI of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the “SEBI ICDR Regulations”), and Sections 42 and 62 of the Companies Act, 2013, as amended, including the rules made thereunder (the “Issue”).

Further to our letter dated 9th August 2023 intimating you about the meeting of the Securities Issue Committee of the board of directors of the Company (the “**Securities Issue Committee**”) to be held on 14th August 2023 in respect of the Issue, we wish to inform you that the Securities Issue Committee at its meeting held today, i.e. 14th August 2023 has, *inter alia*, passed the following resolutions:

- a. Approved the closure of the issue period for the Issue today, i.e., 14th August 2023;
- b. Determined and approved the issue price of Rs.17.55 per Equity Share, i.e. at a premium of Rs.15.55 per Equity Share, which takes into account a discount of 4.83% (i.e. Re.0.89 per Equity Share) to the floor price of Rs.18.44 per Equity Share calculated with reference to the relevant date of 9th August 2023 determined in accordance with the formula prescribed under Regulation 176(1) of the SEBI ICDR Regulations, for the Equity Shares to be allotted to the eligible qualified institutional buyers in the Issue;
- c. Approved and adopted the placement document dated 14th August 2023;
- d. Approved and finalised the confirmation of allocation note to be sent to the eligible qualified institutional buyers, intimating them of allocation of Equity Shares pursuant to the Issue; and
- e. Approved allotment of 113,96,01,139 (One Hundred Thirteen Crores Ninety Six Lacs One Thousand One Hundred Thirty Nine) Equity Shares of face value of Rs.2.00 each to eligible qualified institutional buyers at the issue price of Rs.17.55 per Equity Share, i.e. at a premium of Rs.15.55 per Equity Share, which reflects a discount of Re.0.89 (i.e. 4.83%) on the floor price of Rs.18.44 calculated with reference to the relevant date of 9th August 2023, aggregating to Rs.1999,99,99,989.45 (Rupees One Thousand Nine Hundred Ninety Nine Crores Ninety Nine Lacs Ninety Nine Thousand Nine Hundred Eighty Nine and Paise Forty Five Only), pursuant to the Issue.

Further, the list of the allottees who have been allotted more than five percent (5%) of the Equity Shares offered in the Issue is enclosed herewith and marked as Annexure A.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Company stands increased to Rs.2717,72,39,738/- (Rupees Two Thousand Seven Hundred Seventeen Crores Seventy Two Lacs Thirty Nine Thousand Seven Hundred Thirty Eight Only) divided in to 1356,45,51,516 (One Thousand Three Hundred Fifty Six Crores Forty Five Lacs Fifty One Thousand Five Hundred Sixteen) fully paid-up equity shares having a face value of Rs.2.00 (Rupees Two Only) each bearing ISIN INE040H01021 and 4,81,36,706 (Four Crores Eighty One Lacs Thirty Six Thousand Seven Hundred Six) partly paid-up equity shares having a face value of Rs.2.00 (Rupees Two Only) each with Re.1.00 (Rupee One Only) paid-up bearing ISIN IN9040H01011.

The meeting of the Securities Issue Committee commenced at 7.15 p.m. (IST) and concluded at 7.25 p.m. (IST).

We request you to take the above on record and the same be treated as compliance under the applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
