Note: The paid-up equity share capital of the Company comprises of 1007,30,87,083 fully paid-up equity shares having a face value of Rs.2/- each bearing ISIN INE040H01021 and 240,00,00,000 partly paid-up equity shares having a face value of Rs.2/- each with Re.1/- paid-up bearing ISIN IN9040H01011. The voting rights are considered in proportion to the amount paid-up on the face value of the shares, i.e. Fully paid-up shares x Rs.2 and Partly paid-up shares x Re.1. Accordingly in column IX of Table I, II and III, fully paid-up shares are considered as having one voting right whereas partly paid-up shares are considered as having half voting right.

Note 1: Mrs. Rambhaden Ukabhai, a person forming part of Promoter / Promoter Group of SEL had acquired equity shares of SEL from other persons forming part of Promoter / Promoter Group of SEL as under:

(1) In terms of Gift Deed dated December 21, 2018, 5,90,66,000 equity shares were gifted by Mr. Pranav T.Tanti, out of which 1,65,63,000 equity shares were transferred on December 21, 2018, and post release of encumbrance, 3,000 shares and 4,25,00,000 shares have now been transferred on July 15, 2022 and August 4, 2022 respectively.

(2) In terms of Gift Deed dated February 21, 2020, 6,45,00,000 equity shares were gifted by Mrs. Gita T.Tanti. Post release of encumbrance, the said 6,45,00,000 equity shares have now been transferred on July 15, 2022.

(3) In terms of Gift Deed dated March 31, 2022, Mr. Jitendra R.Tanti, Mrs. Sangita V.Tanti, Mrs. Lina J.Tanti, Mr. Pranav T.Tanti, Ms. Nidhi T.Tanti, Mr. Rajan V.Tanti, Mr. Brij J.Tanti and Ms. Trisha J.Tanti had gifted equity shares held by them to Mrs. Rambhaden Ukabhai which were encumbered. Post release of encumbrance on certain shares held by the said persons, the shares so gifted have now been transferred as under: (i) From Mr. Jitendra R.Tanti – 1,24,00,000 shares and 37,00,000 shares on July 15, 2022 and August 1, 2022 respectively, (ii) From Mrs. Sangita V.Tanti – 7,01,82,000 shares on July 15, 2022, (iii) From Mrs. Lina J.Tanti – 7,01,82,000 shares on July 15, 2022, (iv) From Mr. Pranav T.Tanti – 1,000 shares on July 15, 2022, (v) From Ms. Nidhi T.Tanti – 30,52,000 shares on July 15, 2022, (vi) From Mr. Rajan V.Tanti – 1,66,05,000 shares on July 15, 2022, (vii) From Mr. Brij J.Tanti – 1,96,00,000 shares, 17,000 shares and 1,75,00,000 shares on July 15, 2022, August 3, 2022 and August 4, 2022 respectively, and (viii) From Ms. Trisha J.Tanti – 1,51,20,000 shares on July 16, 2022.

Note 2: In terms of the partition deed dated May 4, 2019, Vinod Ranchhodhbhai HUF (VRT HUF) was dissolved and Mr. Vinod R.Tanti, one of the coparceners in VRT HUF, was in receipt of the entire shareholding of VRT HUF pursuant to such dissolution. Of the entire shareholding of VRT HUF, 1,39,00,000 equity shares were received on May 4, 2019, and post release of encumbrance, 50,00,000 equity shares have now been received on July 16, 2022.

Note 3: In terms of the partition deed dated May 4, 2019, Jitendra Ranchhodhbhai HUF (JRT HUF) was dissolved and Mr. Jitendra R. Tanti, one of the coparceners in JRT HUF, was in receipt of the entire shareholding of JRT HUF pursuant to such dissolution. Of the entire shareholding of JRT HUF, 37,00,000 equity shares were received on May 4, 2019, and post release of encumbrance, 50,00,000 shares and 40,23,000 shares have now been received on July 16, 2022 and August 4, 2022 respectively.

Note 4: Mr. Tulsi R.Tanti, the Founder, the Chairman & Managing Director and one of the Promoters of Suzlon Energy Limited expired on October 1, 2022. Due to this, the list of promoters stands amended w.e.f. October 1, 2022 by deletion of the name of Mr. Tulsi R.Tanti.
