Suzlon announces 85 MW of new orders in India

- **Order valued at Rs. 483 cr (~US\$ 107 mn)**
- **Includes 14.7 MW repeat order from GAIL**
- **Underscores strong growth in Indian wind energy market**

Pune: Suzlon Energy Limited (SEL), India's largest wind turbine manufacturer, announced today cumulative new orders of 85 MW (megawatt) in India.

Tulsi R. Tanti, founder, Chairman and Managing Director of Suzlon said: "India's wind market is unique in its mix of consumers and we strive to meet the varied requirements of each of them. These orders reflect the confidence our customers have in our products and services."

These new orders are from a broad range of customers in corporate, PSU and small/medium business segments. The key customers who have placed orders include GAIL India Ltd. - Asia's leading gas utility company and a 'Navaratna' PSU of the Government of India. The 14.7 MW order from GAIL comprises seven units of Suzlon's S88 - 2.1 MW wind turbines, to be commissioned in Gujarat within six months from the date of order. This is the second wind energy project order placed by GAIL with Suzlon.

Other key orders include Khatau Narbheram & Co, Oswal Group, KRBL Limited, and Varun Industries Limited. It is noteworthy that more than 40 per cent of these orders are repeat business from existing customers - a testimony to Suzlon's market leadership in India.

India has a cumulative installed base of over 14,000 MW, nearly 70 per cent of total renewables input in India. The total estimated onshore wind power potential in India, as per data from the Ministry of New and Renewable Energy (MNRE), is over 48,000 MW. The sector continues on an accelerated growth path driven by demand for power and strong support for renewables by the Government's sound policy framework.
