Suzlon Wind Energy A/S appoints Alf Hansson as Head of Sales in Sweden

This forms the most ambitious climate and energy policy ever presented by a European country and proposes highly ambitious targets including that half of Sweden's energy coming from renewable sources in 2020; Sweden's net emissions of greenhouse gases being equal to zero by the middle of the century with a 40 per cent greenhouse gas emissions reduction target for 2020.
