Suzlon receives 52.5MW order from Gujarat State Petronet Ltd.

- > Repeat order from Gujarat State Petroleum Corporation Ltd. (GSPCL) Group
- Increases group's total wind portfolio to 105MW
- Capacity will be supplied in 35 units of S82 1.5 MW

Pune: Suzlon Energy Limited (SEL), the world's third leading* and India's largest wind turbine manufacturer, has won a major order from Gujarat State Petronet Ltd. (GSPL) to set up, operate and maintain its 52.5 MW wind energy project in the Rajkot and Porbandar districts of Gujarat. The project will be supplied in 35 units of Suzlon's model S82 – 1.5 MW wind turbine generators, and is scheduled to be completed and commissioned by July, 2010. The power generated from this project will be purchased by Gujarat Urja Vikas Nigam Limited under a long term PPA with GSPL.

Gujarat State Petroleum Corporation Limited (GSPCL), the parent company of GSPL, has an existing wind power project of 52.5 MW in the Kutch district of Gujarat supplied, set-up and operated by Suzlon since July, 2009. This new project will take the group's overall wind power installed capacity to 105 MW, all in the state of Gujarat. The process to register existing wind power project with the UNFCC under the Clean Development Mechanism (CDM) program is already initiated, and will also be followed for the new project.

Speaking on the project Mr. Ashok D'sa, President – South Asia and Middle East, Suzlon, said: "GSPL is a leading player in developing energy transportation infrastructure in Gujarat and this repeat order, after the successful execution of the first project for the parent company GSPCL, is an endorsement of our customer's trust in Suzlon's technology, services and capabilities. We acknowledge with gratitude the confidence reposed by GSPL in Suzlon and look forward to strengthening our relationship with the group".

Suzlon has been the top ranked player in Gujarat's wind power sector for many years. Suzlon's Kutch wind park in Gujarat is amongst the largest in Asia with current installed base of over 800 MW and growing. Suzlon's registered office is located in Ahmedabad and the company has substantial footprint across the state with a network of wind farms, offices as well as manufacturing and research and development facilities. Apart from powering the state with more than 900 MW of installed wind power capacity, Suzlon has also contributed by way of sizable direct and indirect employment generation, and
