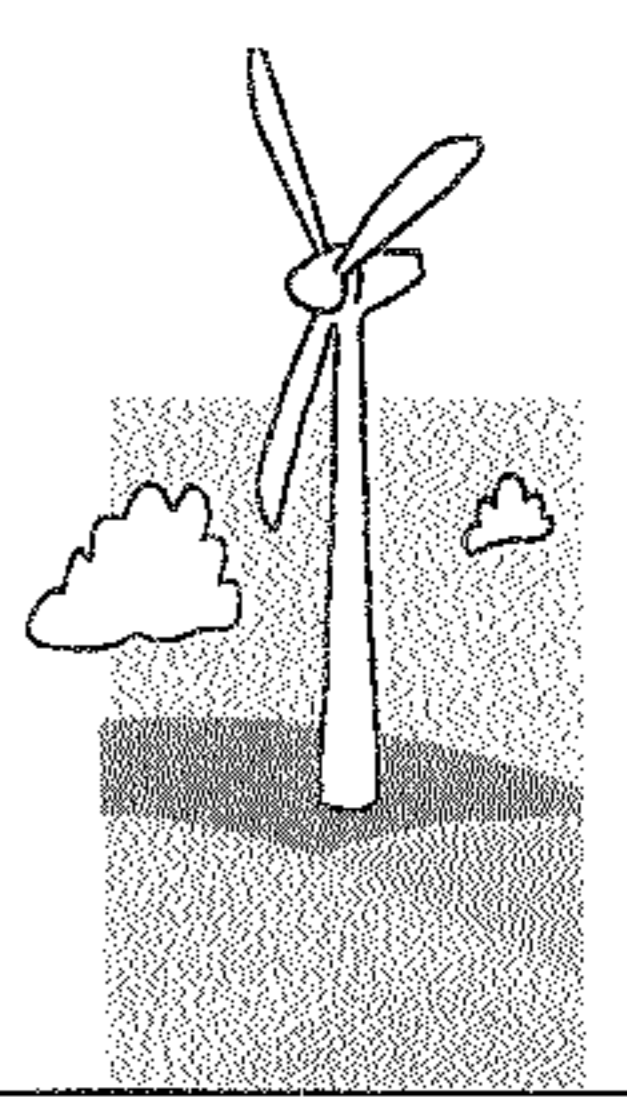

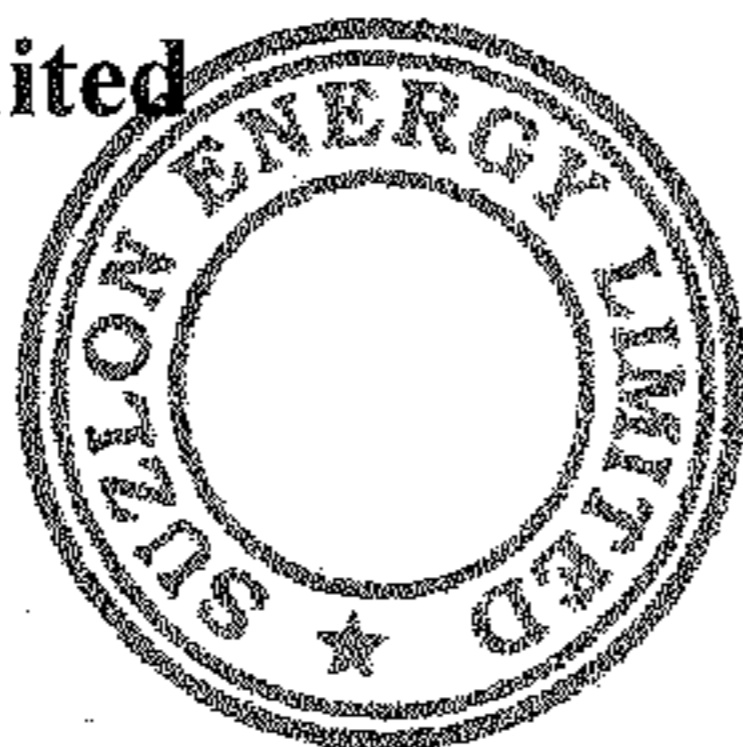

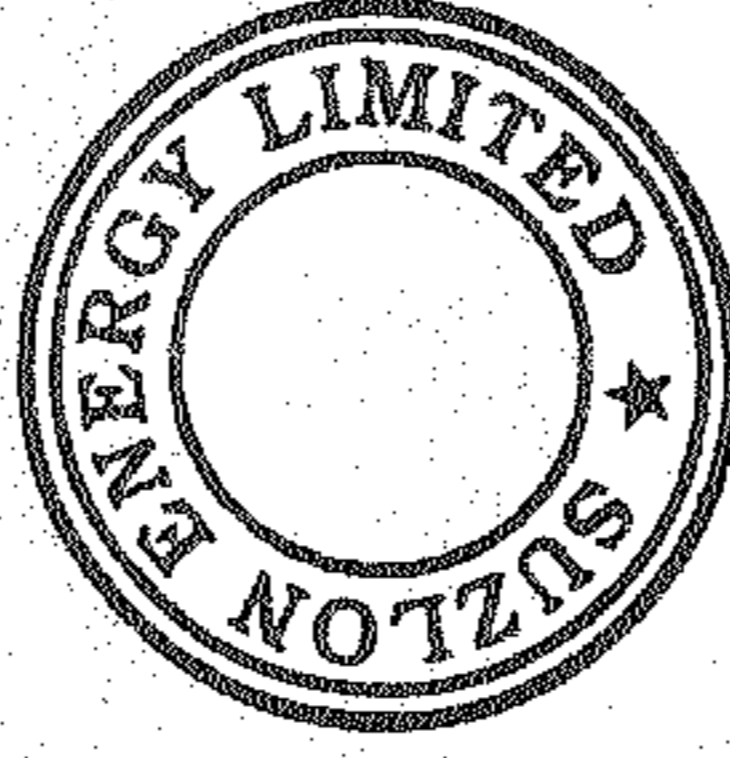

Note:

As informed by the Promoters, the additional pledge of 1.50 Crores shares of the Company representing approximately 1.00% of the paid-up capital of the Company is to offer additional security to various lenders for loans availed of Rs.500 Crores.
