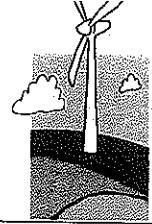

Accordingly, the total shares pledged by the Promoters / persons forming part of Promoter Group after the aforesaid release stands reduced at approximately 38.12%.

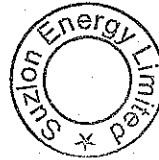
