* Sugati Holdings Private Limited, an entity forming part of the Promoter Group of SEL holding 26,24,97,868 equity shares aggregating to 4.93% of the paid-up capital of SEL has been amalgamated with Samanvaya Holdings Private Limited (Acquirer), another entity forming part of the Promoter Group of SEL with effect from September 04, 2018 (being effective date of amalgamation) by virtue of the Order passed by the Honourable National Company Law Tribunal, Mumbai Bench. Consequent to the said amalgamation, the shareholding of Samanvaya Holdings Private Limited in SEL has increased from 3,30,01,495 equity shares aggregating to 0.62% to 29,54,99,363 equity shares aggregating to 5.55%. However, there is no change in the total shareholding of Promoter / Promoter Group of SEL.
