REpower wins 51MW order from Akuo Energy

Pune: REpower Systems AG (WKN 617703) – in which Suzlon Energy Limited is majority shareholder with 90.71 per cent holding – and the French company Akuo Energy SAS have signed three agreements for the supply of 25 wind turbines. The REpower MM92 turbines, each with a hub height of 100 meters and 2.05 megawatts (MW) of rated power are destined for the three wind farms Fontaine Macon, Sevigny Waleppe and Saint-Germainmont in the Champagne-Ardennes region, in the Northeast of France. Together, the turbines achieve a total generating capacity of 51.25MW.

Akuo Energy SAS develops, operates and invests in renewable energy projects across the world; among these, wind and solar plants are the main focus of the Group. Akuo will build around 500MW in 2010. Speaking on the order Mr. Eric Scotto, CEO of Akuo Energy, stated: "We are delighted to be back on the French Wind market with such reputable partner."

The projects will be executed by the French subsidiary REpower S.A.S. The company is responsible for delivery, commissioning and service of the turbines. Mr. Per Hornung Pedersen, CEO of REpower Systems AG, comments on the closing of the contracts: "We have already set up several wind farms in the Champagne-Ardennes region and are pleased to work with Akuo for the first time. We are confident that this will be the first step towards a global partnership."

Speaking on the order, Mr. Tulsi Tanti, Chairman and Managing Director of Suzlon Energy Limited, said: "France is a very important market for the wind industry, where REpower is a strong and key player. We are pleased with REpower's new order win with Akuo, and are confident that this will be the foundation for a strong long term relationship."

The first set of six wind turbines for the wind farm Fontaine Macon in the Department of Aube will be delivered and commissioned by August 2010. Repower will supply nine REpower MM92 for the wind farm Sevigny Waleppe and ten turbines for the project Saint-Germainmont, both located in the Ardennes Department in 2011, with construction of both projects scheduled for the second quarter of 2011.

REpower's subsidiary REpower S.A.S., headquartered in Paris, is operating on the French market since the end of 2001 and has installed approximately 850MW in France since then.
