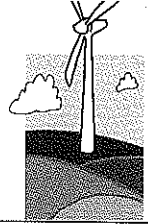

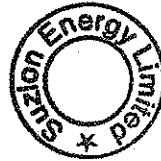
Accordingly, the total shares pledged by the Promoters / persons forming part of Promoter Group after the aforesaid release and additional pledge stands at approximately 35.34%.
